#### **Hong Kong Badminton Association Ltd Affiliated Membership Application**

For all the local sports clubs or organizations which have badminton sports as one of their activities, can become HKBA affiliated members. Each of the clubs or organizations of such type has to submit written application, together with admission fee of \$600 and annual fee of \$360, to the Honorary Secretary of HKBA for consideration. If the application is rejected, all fees shall be refunded to the applicant.

Applicant must complete and submit the Affiliated Membership Application, together with the following information:

- Lists of club office-bearer and member (showing details of the title of the (2) office-bearers and membership classification)
- (3)Club constitution rule details
- Club profiles, past activities and development data (background, history, (4) normal activities.... etc)
- (5) Training venue and time
- (6)Name list of the registered coaches
- (7) Detailed financial /audited reports for the past 2 years

### Basic requirements for admission as an affiliated member:

- $\square$ Has registered in compliance with the "Societies Ordinance" or "Companies Ordinance" or is a registered educational institute
- Has a valid committee member organizational structure  $\square$
- $\square$ Has prepared club constitution, with long term development plan including regular training schedule
- $\square$ Has possessed not less than 20 active members, and supervisory rules for the members
- $\sqrt{}$ Has experienced registered badminton coaches
- $\square$ Financial stability, with detailed financial /audited reports
- $\square$ Active participation of HKBA activities
- $\overline{\mathbf{Q}}$ Accepted to be supervised by HKBA
- $\overline{\mathbf{Q}}$ HKBA possesses the final decision right to approve the membership application. Once it becomes an affiliated member, it must be in compliance with the rules and regulation of HKBA. HKBA shall not tolerate any illegal or unethical behavior. Having endorsed by the board of directors, HKBA has the right to terminate its membership with immediate effect and will be posted at HKBA website and the relevant partnerships shall also be notified.
- $\mathbf{V}$ Affiliated member has the responsibility to update its club data (if for any changes).
